ABOUT WEST VIRGINIA PERSONAL OPTIONS

Personal Options is the self-directed service model within the Home and Community Based West Virginia Medicaid Aged and Disabled Waiver (ADW), Intellectual and Developmentally Disabled Waiver (IDDW), and Traumatic Brain Injury Waiver (TBIW) programs. To participate in Personal Options, an individual must be medically and financially eligible for the eligible waiver services.

In Personal Options, the participant is an employer who hires individuals as an employee(s). Participants may advertise for an employee or hire friends or family members as their employee(s). As an employer they will be responsible for verifying the hours worked by employees and the tasks that were completed. A spouse, legal guardian, or legal representative acting as decision-maker on the participant's behalf cannot be hired as an employee. All employees must meet eligible waiver policy requirements such as age, training, background checks, etc.

Participants have an individualized monthly budget based on his/her assessed needs. Budget funds must be used to purchase needed eligible waiver services such as personal attendant services, RN assessments, and transportation. Case Management is also available to participants in the Personal Options program for no additional fee. Participants do not handle any money directly. All funds are handled by a Fiscal/Employer Agent.

Personal Options allows you to:

- Manage your monthly budget for Medicaid Waiver Services.
- Select, hire, and manage your own employees, including friends and family, to assist you with activities of daily living.
- Determine your employees' schedules and rates of pay (within federal and state limits and approved budget).
- Purchase goods and services, including assistive devices and home medications, to increase your independence at home and in the community.
- Purchase case management services, homemaker RN services, and homemaker transportation services as needed.

Palco financial staff will assist you with responsibilities of managing your budget and being an employer. Palco will:

- File required paperwork for you or your program representative to become an employer.
- Perform payroll and tax functions, including processing timesheets and invoices and withholding federal and state taxes.
- Conduct criminal background checks on all applicants.
- Check provider and vendor qualifications.
- Conduct end-of-year tax reporting.
- Provide timely and accurate information for you to manage your monthly budget.

Palco Resource Consultants are available to assist you with the responsibilities of self-direction. Palco will:

- Help you understand Personal Options.
- Help you develop a plan and budget to meet your needs.
- Provide information and resources to help you hire, train, and manage your employees.
- Provide information and resources to help you purchase goods and services.
- Help you with required paperwork for the eligible waiver programs and Personal Options.
- Help you select a representative to assist you as needed.
